

**Love Without Martinis Survey  
Sweepstakes Rules  
(The “Official Rules”)**

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTRIES RECEIVED FOR THE SWEEPSTAKES PERIOD. VERIFICATION OF ELIGIBILITY, DECLARATION OF COMPLIANCE AND RELEASE REQUIRED. ONLINE ENTRY ONLY AND INTERNET CONNECTION AND EMAIL ADDRESS REQUIRED. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

**1. Eligibility**

The Love Without Martinis Sweepstakes (the “Sweepstakes”) is open to respondents who are legal residents of the fifty (50) United States and the District of Columbia and who are at least eighteen (18) years old as of the date of entry. Respondents must either be a) in recovery from alcohol dependency, currently in a committed relationship with a spouse or partner, or b) in a committed relationship with a spouse or partner in recovery from alcohol dependency. Employees of Accra, LLC and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations.

**2. Sponsor**

The Sweepstakes is sponsored by Accra, LLC, with its official address at 2000 Hamilton Street, Suite 113, Philadelphia, PA, 19130. The Sponsor hereby acknowledges that the Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Facebook and/or Instagram.

### **3. Agreement of Official Rules**

Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

### **4. Sweepstakes Period**

The Sweepstakes begins on April 13, 2018 at 1:00 PM EST and ends on June 15, 2018 at midnight EST (the "Sweepstakes Period"). Entries that are submitted before or after the Sweepstakes Period will be disqualified. Submissions will be accepted for the duration of the Sweepstakes using the following method:

### **5. How to Enter**

- a. Primary Method of Entry: To enter the Sweepstakes, respondent must complete a survey regarding couples in recovery from alcohol dependency, during the Sweepstakes Period.
- b. Alternative Method of Entry ("AMOE"): Respondent sends a letter via postal mail to the Sponsor during the Sweepstakes Period, confirming eligibility and asking to be entered into the Sweepstakes.

Limit one (1) entry per respondent's email address or received mail for the duration of the Sweepstakes Period, regardless of method of entry. Entries received from any respondent exceeding the stated limitation will be void. Entries that are incomplete or do not adhere to these Official Rules may be disqualified at the sole discretion of the Sponsor. Respondent may not enter more times than indicated by using multiple email addresses, sending more than one letter via postal mail, using multiple identities or devices in an attempt to circumvent these Official Rules. If respondent uses fraudulent methods or otherwise attempt to circumvent these Official Rules, such submission may be removed from eligibility at the sole discretion of the Sponsor. All entries become the property of the Sponsor and will not be acknowledged or returned. By entering the Sweepstakes, respondents agree that the Sponsor has permission to send newsletters and communications to your email address.

## **6. Prize Drawing**

On or about June 18, 2018, the Sponsor will select potential winners in a random drawing from among all eligible entries received. Such entries will be entered to a list into the Random Picker online tool. The Sponsor will attempt to notify the potential winner via email on or about June 19, 2018. If the potential winner cannot be contacted within five (5) business days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random with the same Random Picker online tool from the remaining non-winning, eligible entries.

## **7. Winner Notification**

The potential winner(s) will be notified by email. Each potential winner will be required to complete, electronically sign and submit a Declaration of Compliance and Release and Release within five (5) days of the date notice or attempted notice is sent, to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance and Release within the required time-period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance and Release on the potential winners' behalf and fulfill any other requirements imposed on winners set forth herein. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. In the event a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing using the Random Picker online tool with all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prizes will be fulfilled approximately 2-3 weeks after the conclusion of the Sweepstakes.

## **8. Prizes**

The prizes consist of two (2) Amazon.com Gift Cards, each valued at \$100 (one hundred US Dollars), for a combined total of \$200 (two hundred US dollars), to be delivered to the winner(s) by email and redeemable toward millions of items storewide at Amazon.com, subject to Amazon Terms and Conditions.

## **9. General Conditions**

In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Sweepstakes is unable to run as planned for any other reason, as determined by the Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Sweepstakes and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual if it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the full extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

## **10. Release and Limitations of Liability**

By participating in the Sweepstakes, entrants agree to release and held harmless the Sponsor, Facebook, Instagram and each of their respective parents, subsidiaries affiliates, advertising and promotion agencies, other companies associated with the Sweepstakes, and each of their respective officers, directors, employees, shareholders, representatives, and agents (the "Released Parties") from and against any claim or cause of action arising out of

participation in the Sweepstakes or receipt or use of the prize, including but not limited to (a) any technical errors associated with the Sweepstakes, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Sweepstakes; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) any other errors or problems in connection with the Sweepstakes, including, without limitation, errors that may occur in the administration of the Sweepstakes, the announcement of the winner(s), the cancellation or postponement of the event; or (e) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Sweepstakes or acceptance, receipt or misuse of the prize. Entrant further agrees that in any cause of action, the Released Parties liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event, shall the entrant be entitled to receive attorney's fees. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Entrants waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

## **11. Disputes**

Except where prohibited, each entrant agrees that any, and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Philadelphia, PA having jurisdiction. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligations of the Sponsor about the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the United States of America and the state of Pennsylvania, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than those of the state of Pennsylvania.

## **12. Privacy**

Information collected from entrants is subject to Sponsor's privacy policy.
